Mr Combet grew up in western Sydney and worked as a trades assistant, in coal mining, and in a range of community organisations. He has university degrees in mining engineering and economics. He also has a graduate diploma in labour relations and the law. Mr Combet joined the Australian Council of Trade Unions (ACTU) in 1993 and was leader of the ACTU from 1999 to 2007.

Following the Labor Party's Federal Election win in November 2007, Greg was appointed Parliamentary Secretary for Defence Procurement in the Rudd Labor Government. Greg was then appointed Parliamentary Secretary for Climate Change on the 25 February 2009. He was appointed to his current positions on 6 June 2009.
